What is DARS?

- Department for Aging and Rehabilitative Services (DARS)
 - Lead Agency for Disability, including Brain Injury, in Virginia
- Vocational Rehabilitation Agency
- Area Agencies on Aging
- Centers for Independent Living
- Long Term Care Ombudsman Program
- Other smaller departments related to disability and aging



Virginia Brain Injury Council

- Statewide Advisory Council
- The Virginia Brain Injury Council was created in 1986, one of the first in the Country
- More detailed history is provided in the attachment entitled "History of the Virginia Brain Injury Council"
- The mission of the Council is to promote accessible, affordable, and appropriate services for Virginians with brain injury and their families by advising DARS

Current Role

Identify Priorities

 The Council identifies annual priorities related to brain injury and shares those with the DARS Commissioner

Make Funding Recommendations

 The General Assembly requires DARS to consider the recommendations of the Council when allocating new funds for brain injury services

Advise on a Federal Brain Injury Grant

• The Council serves as an advisory board for Virginia's federal Traumatic Brain Injury grant

Advise on State Plan

Council provides input on Virginia's State Plan for Brain Injury Services



Federal TBI State Partnership Program Grant

Authorized by the Federal TBI Act in 1996

- First "Implementation Program" grants distributed in 1998
- Virginia was one of the first

Administration for Community Living

Purpose is to help states increase access to services/supports for individuals with TBI throughout the lifetime. Funded states are expected to:

- Expand/improve state and local capacity so individuals with TBI have better access to appropriate services
- Systems change activities
- These federal funds do not provide "direct service"



A Comprehensive and Coordinated Entry into Services and Supports (ACCESS)

Current Grant Cycle \rightarrow 2021 though 2026

5 grant goals

Advisory Board

 Council serves as advisory board to Virginia's TBI State Partnership Program grant; no oversight

Current Grant Goals

1

• Effective treatment for individuals with traumatic brain injuries (TBI) and cooccurring behavioral health & substance use disorder

2

Supports for caregivers of individuals with TBI

3

• Increased access to and the ability to engage with culturally relevant brain injury specific programs and community-based resources (Years 1-3)

4

• The work of the Virginia Brain Injury Council will reflect the input of individuals living with TBI

5

 Service development driven by accurate data and progress measured through data-based evaluation (Years 4-5)



Review of Orientation Manual



3 Membership Categories

At-Large Voting Members

- At least 50% of the Council is made up of individuals living with brain injury
- At-Large Voting Members serve in a voluntary capacity

Agency Representative Voting Members

- Required by the U.S. Administration for Community Living (ACL)
- Play critical roles in providing, funding, or advocating for services

Ex-Officio Non-Voting Members

- Include state agencies that frequently serve individuals with brain injuries and their families
- Have an important role in improving coordination and access to services



At-Large Voting Members

Individuals Living with Brain Injury (14)

 Provide crucial first-hand perspectives of the needs of individuals with brain injury and their experiences navigating or receiving services

Family Members or Caregivers (3)

• At least 1 is required by the U.S. Administration for Community Living

Public/Non-profit Private Heath Related Organization (2)

Have an important role in improving coordination and access to services



At-Large Voting Members

Submit an application for appointment

- The Nominating Committee reviews applications and makes recommendations to the DARS' Commissioner
- DARS' Commissioner makes formal appointments

Term on Council

- 4 Year Term
- Eligible to serve an additional consecutive term



The Council is committed to the full participation of individuals living with brain injury and their family members/caregivers:

- Provide another "voice" for Virginians living with brain injury and their families/caregivers
- Bring valuable perspectives to the Council's work a "real life" view that balances that of professionals

Council Officer Positions

At-Large and Agency Representative Voting Members can be elected to hold the following officer positions:

- Chair
- Vice Chair
- Secretary
- Immediate Paste Chair
- Family Ombudsman



Staffing

The Council is staffed by the Virginia Department for Aging and Rehabilitative Services (DARS) Brain Injury Services Unit



Member Expectations

Attend quarterly meetings

- Meetings are held on the fourth Wednesday of January, April, July, and October. Council members shall confirm attendance in advance
- At least 2 meetings per year are held in person

Be prepared to participate

- Meeting materials are sent out 10 days before each meeting
- Council members should review meeting materials prior to meetings

Participate on Committees

- Council members are encouraged to participate in at least one committee
- Committees meet virtually outside of the Council quarterly meetings



Council Conduct

- Allow others to speak
- Do not interrupt others

Public Meetings

All Council meetings (including committees) are public.

Quarterly Council Meetings

- Meetings are held from 12:30-3:30 p.m. on the 4th
 Wednesday of January, April, July, and October
- Public comment period is held during every meeting
- DARS Commissioner and DARS Brain Injury Director Updates
- Committee Activity Reports
- Educational Opportunities
- Federal Grant Updates



OPTIONAL: Join a Committee

Priorities

 Prepare the Council's annual "Priorities Letter" for Council consideration (and adoption) to send to the DARS Commissioner

Nominating

- Establish the membership application process
- Solicit nominees to fill Officer positions
- Solicit nominees to fill At-Large Voting Member positions
- Prepare membership recommendations for potential appointment by the DARS Commissioner

Funds Dissemination

 During years that the General Assembly allocates new funding for state-funded brain injury services, this committee reviews budget amendment language and makes recommendations to the DARS Commissioner on dissemination of the funds

Ad-Hoc: Orientation Planning

 Update and redesign the onboarding process for new members

Other committees may be formed as needed



Committees

- All committee work is done virtually
- Each committee elects a chair
- Minutes are kept
- Committees report at the quarterly council meetings

LOBBYING

 Virginia Alliance of Brain Injury Service Providers (VABISP or the Alliance)

LOBBYING

 Brain Injury Association of Virginia (BIAV or the Association)

Lobbying is defined as "a form of <u>advocacy</u>, which lawfully attempts to directly influence <u>legislators</u> or government officials, such as <u>regulatory agencies</u> or <u>judiciary</u>." (Wikipedia)




STATE-FUNDED SERVICES

- With funding allocated by the General Assembly, DARS supports a network of entities that provide brain injury services across Virginia
- Virginia currently has 8 service providers:
 - Brain Injury Connections of the Shenandoah Valley
 - Brain Injury Services, Inc.
 - Brain Injury Solutions (formerly Brain Injury Services of Southwest Virginia)
 - Community Brain Injury Services, Inc.
 - Eggleston Services, Inc.
 - No Limits Eastern Shore
 - The BridgeLine
 - SupportWorks Housing (formerly Virginia Supportive Housing)
- Virginia has 1 provider for statewide resource coordination
 - Brain Injury Association of Virginia
